Meeting notes

Evidence summary

- Consider interpretation of evidence from the International Association for Responsible Drinking (IARD) as they have reviewed similar literature to FSANZ.
- FSANZ invited participants to provide further evidence on cost of labelling changes including SKUs affected.

Warning label design

General

- General agreement for consumer testing of warning label. There is a lack of research to support the proposed warning label.
- Will foods containing alcohol e.g. liqueur chocolates need to carry the warning label?
- FSANZ will consider what alcoholic beverages will need to carry the label. Differing views beverages above 0.5%ABV or above 1.15%ABV.
- Consider evaluation of warning label.
- Consider location of warning label given already required and optional labelling information.
- Consider general requirement for contrasting colour for label, rather than specific colours.
- Consider future proofing for warning label design e.g. include information in QR Codes.
- FSANZ will consider whether outer packaging, hampers etc. will carry the warning label
- Suggestion to use 'pregnancy warning' rather than 'heath warning'.

Size

- Consider flexibility rather than being too prescriptive for size of warning label. Further details could be included in a style guide/guidance.
- Basing label size on % label area would be difficult to implement and enforce.
- Small/medium sized businesses are very concerned about the cost of labelling changes.

Warning statement

- For the proposed statement, use of 'can' is more definitive than 'may'. 'May' preferred given limited evidence.
- Base warning statement on NZ Ministry of Health guidelines, clearer than NHMRC guidelines.
- Suggestion: 'drinking may harm your unborn baby' as statement on alcoholic beverage.
- Support for the current voluntary DrinkWise statement.

Implementation

- Align pregnancy warning labelling with other potential labelling changes from other projects: sugar labelling, carbohydrate/sugar claims on alcohol and energy labelling on alcohol.
- For transition period and allowing for stock-in trade, clarification needed on whether distribution, distributors or manufacturer's storage facilities, customs controlled areas (CCA) are considered 'stock-in-trade'.
- Support the need for evaluation of warning labels after implementation.
